# Anti-slip additive

# **Product Data/ Application Instructions**

Amercoat 886 is a non-sparking natural pumice (50 - 70 mesh) used with mixed units of Amercoat, Amerlock or Amershield coatings to provide an anti-slip finish.

#### Instructions for Use

- 1. Follow all instructions for selected coating for surface preparation, application and dry film thickness.
- 2. Prepare selected coating according to coating application instructions.
- 3. Adjust the quantity of Amercoat 886 anti-slip additive according to volume solids of selected coating. Thoroughly mix the Amercoat 886 anti-slip additive into selected

**Note:** Additive will settle. Mix continuously or stir periodically to maintain uniform distribution.

4. With Amercoat 886 at 1 pint per gallon a conventional industrial spray gun such as DeVilbiss MBC gun with 78 or 765 air cap and E fluid tip with mechanical pot agitator may be used. Agitation is necessary to keep additive in suspension.

With Amercoat 886 at 2 or more pints per gallon, a conventional mastic spray gun such as Binks 7E2 with 64 x 191 nozzle, or Binks 18D with 69C x 191 nozzle, may be used.

5. May also be applied with short nap roller.
